

Profiles in Cowardice

On July 11th, a House Resolution sponsored by **Congresswoman Anna Paulina Luna** (R-FL-13,) charging Attorney General Merrick Garland with "*Inherent Contempt*" of Congress, was defeated 210 to 204 on a floor vote. Garland was previously found in contempt by the House in June, but passage of this H.R. would have fined Garland \$10,000 per day until he complied with an existing subpoena.
