

Intentional Subversion

If Josef Stalin, Vladimir Lenin or Chairman Mao had dictated America's national security policy for the last 50 years, they could not have done a better job of subverting America than the ***New Communist Party of the USA*** -- wrongly called the "*Democrat*" Party -- has done without their direct involvement. Yet, most Americans remain oblivious to this because of the treachery of our corrupt and dishonest Jews' Media.

In *Desert Storm*, the U.S. achieved the most lopsided victory in the history of warfare. Placing a ***REAL*** General like Norman Schwarzkopf in charge was key to that victory, but he was also given the essential weaponry to achieve it. Each of the *state-of-the-art* weapon systems that permitted such a one-sided victory over Iraq had been earlier **cancelled by the Carter Administration**, but later rescued and funded by Reagan's Administration. Among these were the ***Abrams Tank***, the ***Tomahawk Cruise Missile***, the ***B-2 Bomber***, the ***TOW*** anti-tank weapon, and the ***Stinger*** anti-aircraft weapon.

While the Carter Administration was mindlessly cancelling weapons systems in the late 1970s, it **DID** manage to approve the sale of *state-of-the-art* **Bryant Centalign-B** precision ball-bearing grinders to the Soviet Union. These miracles of American engineering produced ball-bearings with tolerances of 27 *ten-millionths* of an inch (.0000027 inches,) and were purchased by the USSR solely to enhance the accuracy of the warheads on their *Inter-Continental Ballistic Missiles* (ICBMs) aimed at U.S. cities. As a result, Soviet ICBMs were soon as accurate as our own. Prior to Carter, the Soviets had more ICBMs with more warheads, but our warheads were far more accurate. This was no longer the case after the Carter Administration approved this sale, and thereby **shifted the "balance of terror"** in favor of the USSR.

Likewise, Jimmy Carter and a "*Democrat*" Senate surrendered the **Panama Canal Zone** to the Nation of Panama in 1979, even though America expended enormous blood and treasure to build it. Arguably, the *Canal Zone* has greater strategic significance than any other geographic entity in the Western Hemisphere, since two-thirds of all shipping to or from the U.S. pass through its locks each day. China now effectively controls the *Canal Zone* after making itself indispensable to Panama through its "*Belt and Road Initiative*," which funds infrastructure projects in many Third World nations. The *Canal Zone* has become the **potential "flashpoint"** that opponents of the *Panama Canal Treaty* had earlier predicted in the 1970s.

For some reason, the NCPUSA has a penchant for **subsidizing our mortal enemies** by bailing out their failing economies, such as that of the USSR in the 1970s. This was alleged to be beneficial because it supposedly demonstrated our benevolent and peaceful intentions toward the Soviets, and was often couched in terms of making *democratic* and *capitalist* allies out of our ideological enemies. This delusional approach to foreign policy is often referred to as "**mirroring**," and implies that totalitarian dictators have similar motivations and goals as Westerners. In reality, U.S. loans and "*trade credits*" to the Soviet Union in the 1970s allowed the USSR to divert resources from its agricultural and consumer goods sectors, and then fund the largest and most **aggressively expansionist military** in modern history.

After the **Soviets invaded Afghanistan** in 1979, they murdered its central government and installed a puppet regime friendly to Moscow. The timid and rudderless Carter Administration did nothing, **signaling its weakness** much like the Biden Administration did by not responding to Russia's invasion of the Ukraine in 2022. (Somehow, Russia's nuclear arsenal effectively deterred the Carter, Obama and Biden Administrations from confronting Russia, but *our own* nuclear arsenal never seems to deter Russian aggression.) The Soviets occupied Afghanistan for 10 years, but were eventually driven out only because the Reagan Administration armed Afghanistan's goat-herders with *state-of-the-art Stinger* surface-to-air-missiles (SAMs,) and *Javelin* anti-tank weapons that generated **MASSIVE** and **UNSUSTAINABLE** losses for the Soviet occupiers.

From the very beginning of his administration, Jimmy Carter sought to pass the second **Strategic Arms Limitation Treaty** or **SALT TWO**. Its adoption was vigorously pursued and relentlessly negotiated, even though the Soviets had previously violated every provision of every treaty it entered into in the 20th Century except the *Hitler-Stalin Pact*. The **SALT ONE** Treaty was an obvious example: the USSR installed ICBM

radar systems, it upgraded "*light*" missiles into "*heavy*" missiles, and it added additional warheads to its ICBMs, all in violation of specific provisions of **SALT ONE**. Clearly, the Soviets used our observance of the *self-limiting* provisions of **SALT ONE** to gain an advantage over the U.S. in terms of the *balance-of-terror*. Yet, this merely prompted the Carter Administration to redouble its efforts to pass **SALT TWO** by **lying and denying** obvious evidence of Soviet violations of **SALT ONE**.

The Clinton Administration was limited by Republican majorities in both Houses of Congress, but still managed to participate in the NCPUSA's tradition of subverting America's national security. In 1996, Bill Clinton personally approved the sale of **Loral Space Corporation's state-of-the-art missile guidance system** to communist China. Because of its **national security implications**, Clinton had to overrule his own *State Department*, *FBI*, *Defense Department* and *intelligence community* (the CFIUS Committee) to approve that sale, but it was worth it. Clinton's reward came in the form of a **BRIBE** from **Loral's** founder and Chairman, Bernard Swartz, and it consisted of a \$6 Million contribution to the **Democrat National Committee** to assist in Clinton's 1996 reelection.



Obama turned a blind eye to most of the corruption and treason in his administration, but some of it he may have helped orchestrate, himself. As Obama's Secretary of State, Hillary Clinton sold 20% of America's

precious Uranium reserves to Russia -- in the so-called "**Uranium One Deal**" -- in return for tens of millions of dollars in bribes from Russian Oligarchs to the **Clinton Family Crime Foundation**. That Uranium is no doubt found in some of those Russian **ICBMs aimed at American cities**, that Vladimir Putin recently referenced in a threatening manner as a means of deterring the U.S. from interfering with his invasion and subjugation of Ukraine.

Obama aggressively pursued the "**Iran Deal**," financially rewarding Iran for sponsoring international terrorism over many decades. It transferred to Iran more than \$150 Billion in Iranian assets frozen in the *Swift System* of international currency exchanges, and included a "*gratuity*" in the form of \$2 Billion in U.S. \$100 bills. In return, the Obama regime received vague and unverifiable promises from Iran not to pursue its nuclear weapons program, but Iran took the money and continued *full-steam ahead*. The treaty's real purpose was to **empower Obama's fellow Moslems**. It was also considered useful in creating the illusion of a foreign policy "*victory*" to enhance Obama's image. Obama's arming of Iran in the **Iran Deal** will continue to generate terrorism and cost innocent lives for decades to come in the Middle East.

Likewise, under the Obama Administration, Hunter Biden and his partners at **Rosemont Seneca Partners** received an unprecedented windfall of \$1.5 Billion from communist China to invest. In return for its generous patronage of Hunter Biden's influence-peddling scheme, communist China's government -- through its **Aviation Industry Corporation of China** -- was permitted to purchase Michigan's **Henniges Automotive**, a producer of strategic technologies that reduce engine vibrations to enhance the "*stealth*" features of military equipment. Despite the fact that it involved **stealth technology with military applications** -- sold to our mortal enemies -- the sale was approved by Barack Hussein Obama, who had to first overrule any objections by CFIUS, the **Committee on Foreign Investment in the U.S.**

The Obama Administration also showed its loyalty to Russia when Obama **refused to assist the Ukraine** after Russia invaded it for the *first* time back in 2014. Instead of sending weapons or deploying forces, **Obama sent them blankets**. (A guy *could* be left with the impression that Obama felt greater sympathy for the neo-communists in Putin's Russia than with the fledgling and non-communist nation of Ukraine.)

As traitorous and subversive as prior NCPUSA administrations may have been, none can rival the Biden Administration for pure treachery. Under Biden, the NCPUSA's domination by communists and crooks has been complete and irreversible. The day he took office, Joe Biden cancelled the **Keystone XL Pipeline** from Canada and forbade oil and gas exploration and "*fracking*" on federal lands, which immediately obliterated **America's energy independence** by harming domestic oil production. Meanwhile, he approved Russia's **Nord Stream** gas pipeline that created Western European (and NATO) dependence on Russian gas.

Biden's arbitrary and capricious actions doubled the worldwide price of crude oil in only one year, creating a windfall for Russia's oil and gas exports, and dramatically enriching its coffers. In doing so, Biden also helped to **fund Russian expansionism**, with its brutal and unprovoked invasion of the Ukraine since 2022.



Biden demonstrated his weakness and cowardice with his disorderly and humiliating 2021 **retreat from Afghanistan**, abandoning \$85 Billion worth of state-of-the-art military equipment and hundreds of American citizens to the bloodthirsty savages of the Taliban. With equal treachery, he has opened America's southern border and welcomed two million **illegal aliens** into America from 150 different nations **without any vetting** of their criminal histories or their motivations for illegally entering the U.S. (Many will prove to be terrorists.)

Finally, Biden has waffled and vacillated and "*led from behind*" in responding to Russia's unprovoked and brutal **invasion of the Ukraine**. Initially, he relied exclusively on empty rhetoric involving economic sanctions when he should have sent **Stinger** and **Javelin** defensive weapon systems to the Ukraine long before Russia's invasion made them more difficult to deliver. He also practically invited Russia to invade the Ukraine's Eastern Provinces when he clumsily attempted to distinguish between a full-fledged invasion and a "*minor incursion*," implying that the latter was somehow acceptable to the U.S. and NATO. Worse yet, those economic sanctions were all form over substance because they **specifically excluded** the freezing of Russia's oil and gas revenues through the **Swift System** of international currency transactions.
