

The Architect of 9-11

When the Soviet Union began to disintegrate in 1991, America's domestic enemies lost their greatest ally. Marxists of every stripe had always expected the *Soviet Bloc* to provide the ideological discipline to conquer America and impose a Soviet-style dictatorship upon its vanquished foes in the U.S. After 1991 and much to the dismay of America's domestic enemies, the Soviets no longer had the "*muscle*" to effectuate that 100 year-old dream.

Looking around following the Soviet Union's collapse, it was easy to recognize that radical Islam offered a potential substitute for the former *Soviet Bloc*. Most adherents to radical Islam are probably best described as "*Islamic Marxists*," making this new alliance an easier *fit* than one might have presupposed. And, like the Soviets before them, radical Islam wasn't squeamish about violence: with the exception of crude oil, violence and terrorism are about the only things radical Islam is capable of exporting.

With the election of Bill Clinton in 1992, immigration became a very high priority for the ***New Communist Party of the USA*** (NCPUSA,) often mistakenly called the "*Democrat*" Party. It was particularly partial to Muslim immigration from the Middle East and Africa, and all kinds of radical Islamic terrorists and other *Third World* garbage found their *visa* applications approved, and many became U.S. citizens. For example, hundreds of thousands of Somalis were admitted, who are now the primary source of violent crime in certain Minneapolis neighborhoods.

In addition to Islamic terrorists, the Clinton Administration also harbored a sympathy for Puerto Rican Marxist terrorists. In 1999, Bill Clinton commuted the sentences of 16 FALN terrorists who had detonated over

100 bombs in large cities such as New York and Chicago in the 1970s and 1980s. *Slick Willie* also pardoned two members of the *Weather Underground*, one of whom was in possession of 740 pounds of dynamite and another who participated in the bombing of the *U.S. Capitol Building* in 1971.

It was during the Clinton Administration that Usama Bin Laden orchestrated the first attack on the ***World Trade Center*** in 1993, and later detonated a truck bomb at the *Saudi National Guard Communications Center* in Riyadh that killed two American soldiers in 1995. Another of his truck bombs killed 19 Americans at Saudi Arabia's ***Khobar Towers*** in 1996, and suicide bombings by Al Qaeda at U.S. embassies in Tanzania and Kenya later killed 12 Americans. His attack upon the ***U.S.S. Cole*** in 2000 killed 17 sailors. **THREE TIMES CLINTON WAS OFFERED USAMA BIN LADEN ON A SILVER PLATTER BY FOREIGN GOVERNMENTS, BUT ALL THREE TIMES HE REJECTED THOSE OFFERS.**

With its obvious fondness for domestic Marxist terrorists, the Clinton Administration needed to "cover" itself and the NCPUSA, just in case there might be political ramifications. In 1994, Clinton had already seen the NCPUSA lose the House (and Senate) for the first time since 1952, and recognized his own political vulnerabilities along with those of his party. It was predictable that some of the African and Middle Eastern garbage granted U.S. citizenship and *visas* would eventually engage in acts of terrorism here, and the NCPUSA's culpability had to be hidden from the electorate.

Clinton's solution was to appoint a Jewess named Jamie Gorelick as Deputy Attorney General under Janet Reno. Here was a seasoned "deep state" operative, who immediately set about to protect her ideological comrades. She issued the now-infamous "GORELICK MEMO" that prevented both the CIA and the FBI's *Intelligence Division* from sharing information with the FBI's *Criminal Division*. This was

clearly done to shield the Clinton Administration from any repercussions from having admitted terrorists posing as immigrants, who might eventually embarrass the administration and NCPUSA with terrorist acts. The consequences of the Gorelick Memo were the events of September 11, 2001.

Here is the *Gorelick Memo* in her own words: ***“We believe that it is prudent to establish a set of instructions that will more clearly separate the counterintelligence investigation from the more limited, but continued, criminal investigations. These procedures, which go beyond what is legally required, will prevent any risk of creating an unwarranted appearance that FISA is being used to avoid procedural safeguards which would apply in a criminal investigation.”*** (Editor's emphasis.)

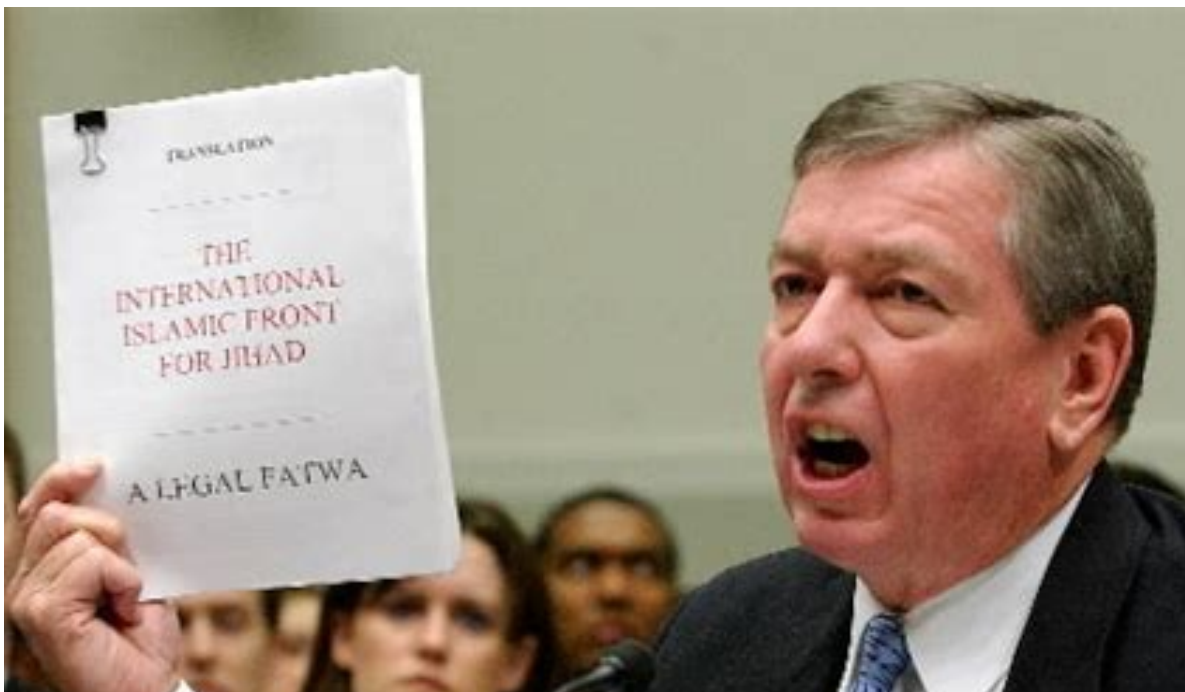
In practice, the *Gorelick Memo* created a legal "**WALL OF SEPARATION**" between the intelligence community and law enforcement agencies. Theoretically, even the FBI's *Intelligence Division* could not share intel with its *Criminal Division*, (or at least the *Criminal Division* could not act upon any intel it was given.) Likewise, the CIA was prohibited from sharing intel with the FBI. One consequence was that in 2000 and 2001, the FBI's Criminal Division remained unaware of multiple FBI field office reports of sweaty Moslems in Florida and elsewhere learning to fly *Boeing 747s*, but having no interest in learning how to *LAND* them. The CIA knew they belonged to *Al Qaeda*, and it was also aware they planned to commit terrorist acts with commercial airplanes, but both the CIA and the FBI's Counter-Intelligence Division were prohibited from sharing their evidence with the FBI's Criminal Division.

In his testimony before the *9-11 Commission*, George W. Bush's Attorney General, John Ashcroft, made the following statement:

"In the days before September 11, the wall specifically impeded the investigation into Zacarias Moussaoui, Khalid al-Midhar and Nawaf al-Hazmi. After the FBI arrested Moussaoui, agents became suspicious of his interest in commercial aircraft and sought approval for a criminal warrant to search his computer. The warrant was rejected because FBI officials feared breaching the wall." (Emphasis mine.)

Likewise, the CIA may have been so intimidated by the *Gorelick Memo*, it twice declined to add Nawaf al-Hazmi and Khalid al-Mihidhar to the government's ***Terrorist Watch List*** in 2000. After the CIA finally alerted the FBI in late August of 2001 that al-Mihidhar and al-Hazmi were in the U.S., were members of *Al Qaeda*, and were up to no good, FBI agents in the New York field office began to search for them. **However, because of the *Gorelick Memo*, FBI headquarters in Washington prohibited the FBI's *Criminal Division* from joining that investigation.**

In his testimony, Ashcroft was referring to the following series of events: a concerned instructor at the *Pan-Am International Flight Academy* in Eagan, Minnesota notified Agent Harry Samit at the FBI's Minneapolis Field Office of his concerns about the behavior of a certain Middle Easterner who was enrolled in that flight school and obsessed with the school's *747-400 Flight Simulator*. That suspicious individual was Zacarias Moussaoui, one of the 9-11 hijackers, who was quickly arrested on August 11, 2001 for violations of his immigration status.

Moussaoui rejected Agent Samit's request to search his hotel room and laptop computer, so Agent Samit twice petitioned the FBI to obtain a search warrant to do so. **After the first request for a conventional search warrant was denied, Samit then requested a FISA warrant to conduct a search, but BOTH REQUESTS WERE DENIED BY FBI HEADQUARTERS.** Samit then courageously attempted to directly notify

the ***Federal Aviation Administration*** (FAA,) in order to warn them of his suspicions that terrorists planned to hijack airliners, **BUT FBI HEADQUARTERS CENSORED HIS ATTEMPTED WARNING TO THE FAA, AS WELL.**

Agent Samit testified at Moussaoui's criminal trial that he spent the days between August 11 and September 11, 2001 trying to find someone who would listen to his fears of impending terrorist attacks against the U.S. using hijacked aircraft to accomplish this atrocity. He testified under oath that the FBI's failure to act on his warnings indicated "***criminal negligence, obstruction and careerism***" at FBI Headquarters. **Agent Samit was also warned by superiors that voicing his concerns too aggressively could harm his career.**

Those at the upper-echelons of FBI Headquarters who ignored Agent Samit's warnings were almost certainly intimidated by the *Gorelick Memo*, which mysteriously managed to survive into the first year of the new Bush Administration. If the FBI had taken Samit's warnings seriously, the catastrophe of September 11, 2001 might well have been averted.

Astute readers may recall that the top echelons of the FBI were perfectly willing to commit perjury before four FISA Courts for warrants to spy on and frame candidate and President Donald Trump for four years with the phony charge of "*Russia Collusion*," but 20 years earlier were unwilling to seek FISA warrants to investigate potential Islamic terrorists whose hijackings of airliners produced the catastrophe of 9-11. **This irony perfectly illustrates the extent of the treasonous decline at the FBI after eight years of Bill and Hillary Clinton, and eight more years of Barack Hussein Obama.**

In a classic example of the manner in which "*deep state*" traitors protect and run interference for one another -- much as the Jewish

communists who spied for the USSR during Franklin Roosevelt's Administration had done in the 1940s -- Jamie Gorelick was appointed to serve as a **COMMISSIONER** on the *National Commission on Terrorist Attacks Upon the United States*, or the "*9-11 Commission*" that issued the official report of that disaster. We have former Attorney General John Ashcroft to thank for calling her out by name in his testimony before the *9-11 Commission*, and exposing the *Gorelick Memo* to those who cared to listen. Were it not for Ashcroft's testimony, the public might never have heard of the *Gorelick Memo*.
