

Biden's *Clown Show*

The Biden Administration will inevitably fail, much like the Carter Administration of the late 1970s and for many of the same reasons. Biden will attempt to placate the communists, race-hustlers, queers, Bolshevik Jews, Muslims, feminists and all the other traitorous garbage in his party by adopting policies that will be disastrous for America. Like Jimmy Carter before him, his **failures will compound** until he and his administration become a laughingstock.

Biden will no more be in charge of his own presidency than Carter was. Like Carter, he will be a **mere puppet**, whose puppet-masters are wealthy Jews like George Soros, Michael Bloomberg, Mark Cuban, and Tom Ayres, and plutocrats like Bill Gates, Mark Zuckerberg and Jack Dorsey: they will call the shots in the ***New Communist Party of the USA***. (NCPUSA,) often laughingly called the "*Democrat*" Party. The policies Biden adopts will **inevitably fail**, and even the lies and disinformation of the Jews' Media won't prevent the **electorate from recognizing this fact**.

HIGHER TAXES: Increasing taxes has always animated the NCPUSA, not because its members are concerned with fiscal responsibility or budget deficits, but because increased Treasury Revenues provide it greater opportunities to **transfer wealth** from its political opposition to its political supporters. That has been their ***ONLY* playbook** since FDR. Biden has promised to raise Federal Income Tax rates, Capital Gains Tax rates & Corporate Income Tax rates, thus thwarting any possible recovery from the *ChinaVirus* and the recession it has spawned.

No honest economist or businessman with an ounce of sense believes that increasing **ANY** tax will do other than slow economic growth. Moreover, raising Corporate Tax rates will, once again, drive many American corporations to retain profits "*off-shore*" in foreign subsidiaries rather than pay the higher tax bill they would incur by repatriating those profits back into the U.S.

On top of this, the Biden Administration also plans to pander to its **radical "environmentalist" base** by returning to the *Paris Climate Accords*, a **United Nations** scam to transfer our wealth to the Third World, all in the name of combatting "*global warming*." Even though the U.S. has led the entire world in reducing our carbon "*footprint*," this will take place, anyway, because America's wealth is always in demand by Third World dictatorships and other *shit-holes*.



HIGHER UNEMPLOYMENT: The Biden Administration's blizzard of new regulations on business and industries, its enthusiasm for continuing COVID lockdowns and a higher federal Minimum Wage will inevitably **damage the economy** further, including increased unemployment.

It's an empirical fact – demonstrated countless times – that higher minimum wage rates invariably cause **HIGHER** unemployment as an inevitable consequence. A government-mandated Minimum Wage rate of \$15 per hour will force employers to terminate or "*dis-employ*" less productive workers who are no longer affordable at the higher mandated minimum wage. Most of those "*shuttered*" restaurants and bars in **Blue** states will never reopen if the Minimum Wage is raised to \$15 per hour.

Moreover, Biden's proposals to **re-open our southern border** will permit the entry of millions of additional, low-skilled and poorly-educated *Third-Worlders*, who will compete with and thereby drive-down wages for low-skilled Americans in high immigration areas such as southern California. Many of these new immigrants will also avail themselves of America's generous welfare programs as an alternative to gainful employment, just as more than 70% of all Hispanic immigrants have done for decades.



SLOWER GROWTH: The Biden Administration's arbitrary and capricious interference in the form of new regulations will also slow the U.S. recovery. For example, by cancelling the *Keystone XL Pipeline*, Biden immediately dis-employed tens of thousands of highly skilled and well-paid steel workers, welders and heavy-equipment operators who were in the process of building it. Biden has also prohibited oil drilling on public lands -- despite many promises not to do so -- and has vowed to end "*fracking*" in a determined effort to destroy the oil services industry.

These policies will dramatically **raise the cost of ALL petroleum products** including gasoline, diesel fuel, home heating oil and petrochemicals. The Biden Administration plans a similar **war on coal**. After four years of energy independence, this will make America reliant once again upon imported oil from unstable Middle East suppliers, while simultaneously damaging valuable domestic energy industries and their employees.

When questioned about the high-paying jobs he will kill in the energy industry, Biden's response was to recommend that coal-miners and oil services workers "*retrain*" to become computer-programmers, a statement that ranks up there with "*Let them eat cake,*" the advice supposedly offered by Marie Antoinette when she was informed that the peasants had no bread.



INFLATION: The Biden Administration and the NCPUSA will engage in **mindless spending** – just as it has done for decades – most of which must be *monetized* by the Federal Reserve in the form of newly-printed money. Profligate spending in the form of "*Reparations*" to blacks for slavery, the \$1.9 Trillion "Stimulus Bill," forgiving trillions of dollars in federally guaranteed student loans for our budding revolutionaries in "*higher education*," and trillion-dollar "*Omnibus Spending Bills*" will generate enormous pressures on the Fed to monetize vast amounts of debt. Inevitably, this will result in the kind of **inflationary pressures** that the U.S. hasn't seen since the Carter years.



REWARD THE UNDESERVING: The Biden Administration and the NCPUSA clearly endorse legislative initiatives to **reward profligate Blue states** like California, New York, Illinois and New Jersey with "**bailout**" **money** to cover their irresponsible and inexcusable spending habits. Provisions for such bailouts have been included in every proposed "*stimulus*" bill written by the NCPUSA over the last decade, and they are one of the reasons no such bill was passed until Biden came along.

Likewise, there is a great deal of enthusiasm within the administration and the NCPUSA to **transfer wealth** in the form of "*Reparations*" from whites who **NEVER OWNED** slaves to blacks who **NEVER WERE** slaves. This would reward the laziest and most criminal race in this country's history for its endless looting, "*flash mobs*," murders, violent crime rates, arson, illegitimacy and property crimes, in addition to the enormous expense of processing them through the criminal justice system and incarcerating them.
