

# Black Self-Government

Tiffany Henyard -- the black mayor of Dolton Village and Supervisor of Dolton Township, Illinois -- has been christened the "**worst mayor in America**" by many observers of her clown show. However, she's got no shortage of competition among every other black mayor in America, so that may well be an exaggeration.

According to an audit by former Chicago Mayor Lori Lightfoot -- no slouch herself when it comes to misgoverning -- beginning in 2021, Mayor Henyard and her administration repeatedly obscured the true financial condition of Dolton Village from trustees and the public. That's because she and her cronies were busily embezzling and misappropriating millions of dollars of city funds.

**With the ease that *Jesus Christ* turned water into wine, Henyard managed to convert a \$5.61 Million surplus in April of 2022 into a \$3.65 Million deficit by May of 2024.**

Lightfoot's report indicates that between 2021 and 2024, Henyard's administration charged \$780,000 to Dolton Village's credit cards, with very little itemization of these expenses. Expenditures that *were* verifiable included \$171,000 that funded all expense-paid junkets by Henyard and many friends to Las Vegas. Not surprisingly, these junkets never translated into any business opportunities for Dolton Village.

The *Lightfoot Report* also indicates that \$50,000 was spent on local restaurants, \$218,000 on **Amazon** purchases, and another \$7,000 was spent on Henyard's makeup team. There were also numerous credit card purchases made at **Best Buy, Wayfair, Walgreens, Dick's Sporting**

**Goods, Apple, and Walmart.** Naturally, there are few if any receipts available to indicate the specific items purchased.

In 2021, Dolton Township also received approximately \$3 Million from Biden's phony "*American Rescue Plan*," a scam to transfer wealth from working Americans to "*Democrat*" Party constituents. Of course, Henyard failed to appoint a conservator to oversee those federal funds, a requirement of the **Treasury Department**, so hundreds of thousands of dollars are missing and without receipts.

**By August of 2024, Dolton's trustees wisely confiscated Henyard's credit cards, and hired Lori Lightfoot to forensically audit the village's finances.**

Lightfoot revealed the results of her investigation at a recent town hall meeting, where those in attendance asked her several times if Henyard was subject to criminal charges. Lightfoot wisely declined a specific answer, because malfeasance and embezzlement are charges that could easily be brought against most of America's black public officials, including herself.

That meeting where Lightfoot gave her report took place one day after a separate meeting of Dolton Township. The earlier meeting erupted into a brawl that involved Mayor Tiffany Henyard, her boyfriend and her supporters, pitted against their numerous and enraged critics.
