

Out of Touch

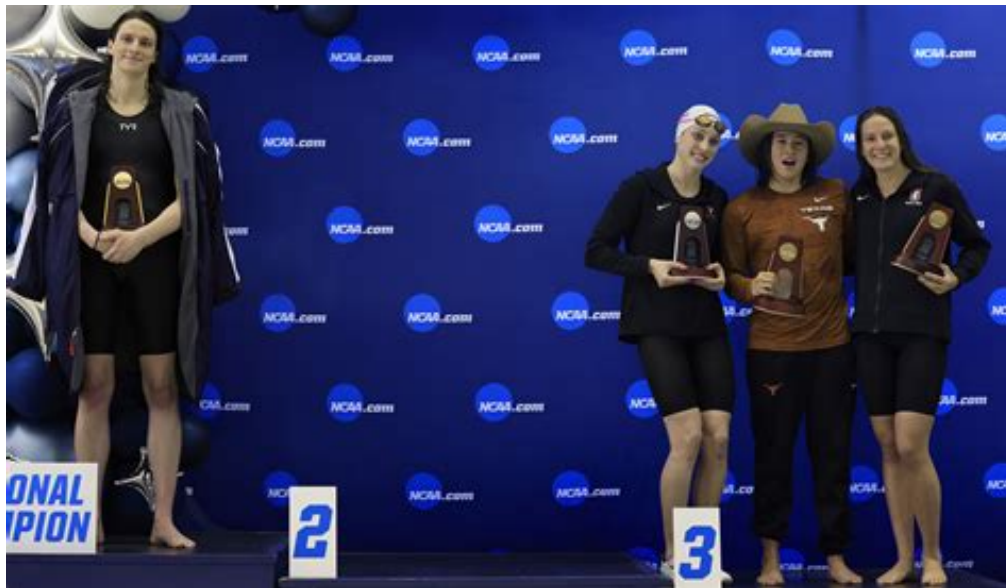

"Populist" movements evolve when a sufficient number of ordinary citizens recognize they have more smarts and better judgement than the fools who misgovern them. This was evident when the *Soviet Bloc* disintegrated in the 1990s, and it's equally applicable today in America. For the last four years, we've been governed by a *triumph of idiots*, who will be remembered as the most corrupt, incompetent and subversive losers that Washington, DC has ever witnessed.

Inferring motives can be problematic, but in the case of the ***New Communist Party of the USA*** (NCPUSA) -- often wrongly called the "*Democrat*" Party -- its motive has been patently obvious for decades. As a party, the NCPUSA consists of numerous constituencies that despise America and the principles on which it was founded, so for the last 30 years it has dedicated itself to destroying this nation and our Constitution. Since the 1990s, they have relentlessly pursued power by promoting truly insane policies.

Long ago, the NCPUSA realized the only way to maintain its ***"Rainbow Coalition"*** envisioned by Jesse Jackson was to welcome anyone, even mentally-ill ***"transgenders,"*** pederasts, corrupt teachers' unions, illegal aliens, radical Moslems, ***Birkenstock Bolsheviks, swamp creatures,*** and other criminals. However, once these groups became reliable voting blocs, the NCPUSA suddenly found itself obligated to return the favor by supporting the toxic political agendas of each. Recently, that placed the NCPUSA in the incredibly awkward position of promoting the delusional ***mantra*** coined by feminists -- ***The Ladies' Auxiliary of Marxism*** -- that ***"gender is a false construct."***

By the 2024 Election, this meant that the NCPUSA found itself in the unenviable position of supporting "*transgendered*" males who compete against biological females in athletic competitions. These **female impersonators** often steal victories from more deserving *female* athletes, and sometimes seriously injure them while competing. Yet, all but two of the NCPUSA's House members voted against the ***Protection of Women and Girls in Sports Act*** (HR 28,) enacted in January of 2025. This revealed the NCPUSA's misplaced sympathy for mentally-disturbed "*transgendered*" over their injured or displaced female opponents, who devote much of their lives to training for their sport.

The NCPUSA was also obligated to defend "***gender counseling***" of grade school kids, and sometimes without parental knowledge or consent. So of course, the Biden Administration heavily funded this insanity in at least two federal budgets. This authorized the same political party that can't define what a woman is to instill the idea among young and impressionable children that they might have been born with the

"wrong" gender. Once again, the NCPUSA showed greater affinity for the pederasts and circus freaks who masquerade as *gender counselors*, than for parents or grade school kids, themselves.

Much of what's wrong with public education can be traced to grifters and frauds at the federal ***Department of Education*** (DOE.) That's where most of the truly destructive and laughable ideas originate, such as "*No Child Left Behind*," "*Ethno-Math*" with no wrong answers, and *Critical Race Theory*. As a result, increased levels of spending on public education have produced dramatically lower standardized test scores. However, for years the NCPUSA has thwarted desperately needed **education reforms** like *school choice*, local control, minimum standard for teachers, and eliminating the fraud known as "*teacher certification*." As usual, the NCPUSA showed solidarity with the teachers' unions -- which are killing public education -- rather than students, parents, or taxpayers.

Open borders have welcomed the trash of the Third World -- including tens-of-thousands of murderers, rapists and terrorists -- who were transported here by the Biden Administration. Moreover, many NCPUSA officials have adopted "*sanctuary laws*" to protect illegals, while refusing to cooperate with immigration authorities. Many Americans have been raped, murdered, or poisoned with *Fentanyl* by psychopathic gangs and sociopathic drug cartels. Sanctuary laws are compelling evidence that the NCPUSA is more supportive of dangerous illegal aliens than of innocent and legal American citizens, who are often their victims.

The NCPUSA also persists in viewing criminals as victims and cops as bad guys. That's the only reasonable explanation for why most **BLUE** cities run by the NCPUSA have defunded the police and initiated other, phony "*justice reforms.*" Many have waived cash bail, granted early parole for violent felons, and de-criminalized serious offenses. Several **BLUE** states have also worked to reinstate the voting rights of convicted felons who served their sentences. By pandering to criminals while penalizing police, these cities revealed greater empathy for criminals than for the innocent citizens who become their victims.

Following Israeli retaliation against Hamas terrorists who invaded their nation on October 7th of 2023, thousands of **paid demonstrators** disrupted campuses at once-prestigious universities located in **BLUE** cities, such as **Columbia, NYU** and **Yale**. Despite the destruction of property, threats of violence against Jewish students, obstructing class attendance, and the "occupation" of university buildings, few if any demonstrators were ever arrested and charged with civil rights violations. Most university administrators are "progressive" members of the NCPUSA, and clearly commiserate with terrorists and their proxies rather than with the 1,200 innocent Israeli civilians massacred by Hamas, or those innocent students wishing to attend class.
