

They *NEVER* Let You Down (cont'd)

If you needed further evidence that blacks are **NOT** even remotely capable of self-government, get a load of this story: an ex-convict hired by the District of Columbia as a "*Violence Interrupter*" has been charged with first degree murder. You can't make this stuff up and -- thanks to *you-know-who* -- you don't need to!

In 2018, a former negro prosecutor for the city of Washington, DC, began a program to curb gun violence in that city called "*Cure the Streets*." One of his brilliant ideas was to hire convicted felons as *violence interrupters* due to their greater familiarity with the subject at hand. The former prosecutor -- a guy named Karl Racine -- subscribed to the quaint theory that gun violence was a "*disease*," and that *violence interrupters* would be immune to criminality because they were already reformed, or in his words, "*transitioned*." (This probably encouraged federal grants from the *National Institutes of Health*.)

In theory, the presence of *violence interrupters* preempts the need for a police presence during potentially violent confrontations, and was a gesture in the direction of so-called "*justice reform*." In 2020, *justice reform* became popular in **BLUE** cities run by incredibly stupid blacks where, not surprisingly, the VAST majority of all violent crimes occur. *Cure the Streets* was designed to operate in DC's most dangerous neighborhoods, which is now pretty much all of them except for Georgetown and Capitol Hill.

A man named Cotey Wynn was one such hire by *Cure the Streets*, but he was recently arrested and charged with first degree murder following a nightclub shooting. Wynn was hired despite his lengthy rap-sheet, one that included felony murder, first degree murder, possession with intent to distribute crack cocaine, and the actual distribution of a controlled substance. Karl Racine, DC's chief legal officer, hired him anyway.

At the time he was hired, Cotey Wynn had engaged in yet, another fatal shooting, but he was not arrested and charged until 2020. At the time of the earlier shooting, he was under the supervision of DC's ***Pretrial Services Agency***. The latter is a federal agency traditionally staffed with people who believe that preventative detention of violent and dangerous n*ggers ought to be used only as a last resort. This was also a gesture in the direction of the *justice reform* foolishly taking place in many **BLUE** cities. Corey Wynn clearly saw his new job as an opportunity to illegally carry a concealed weapon and continue his life of crime.

This scandal coincides with that of two other black criminals on DC 's violence prevention payroll. One is a former DC Councilman named **Trayon White**, who was recently expelled from office and now faces federal charges of accepting \$156,000 in bribe money. He is accused of using his former office to pressure two of the city's anti-crime agencies to extend several existing contracts amounting to \$5.2 Million. White is scheduled for trial in 2026.

More recently, the former Deputy Director of the ***Office of Neighborhood Safety and Engagement*** (ONSE,) named **Dana McDaniel** pled guilty to accepting

\$10,000 in bribe money . She was charged with using her position to award contracts and grants to a business owned by her friend, who wished to provide resources and services for the legions of *Future Felons of America* currently residing in Washington, DC. McDaniel faces 15 years in *The Slammer*.

It hardly needs mentioning that, despite the enormous amounts of tax-money thrown at violent crime prevention in DC, the problem continues to accelerate. That's the way it is with blacks: they are no more capable of solving society's problems -- many of their own making -- than they are of landing a man on Mars. However, they sure are gifted at creating legions of government agencies and then embezzling from them.

If there's a lesson to be gleaned from this sordid tale, it's that the ***U.S. House of Representatives*** needs to rescind so-called "*Home Rule*," and return to its traditional role of governing Washington, DC. There's absolutely ***NO OTHER WAY*** for DC to avoid remaining a cesspool of violence, incompetence, embezzlement, and nigra tribalism. ***TRUE DAT!***
