

## CofCC's "*Russia Collusion*" Reportage

Every journalist mentioned above, both reporters and opinion journalists, helped to untie the ***Gordian Knot*** created by Obama's ***Operation Crossfire/Hurricane***. ## IT ALL BEGAN WITH HILLARY CLINTON:

### **OBAMA WAS THE ARCHITECT OF ALL SUBSEQUENT EFFORTS TO DESTROY DONALD TRUMP:**

During the 2016 election, Hillary's accusation of Trump's "*Russian collusion*" was quickly seized upon by Barack Hussein Obama and his minions. Illustrating this fact were the infamous e-mails between the Chief of the *FBI's Counterespionage Section*, Peter Strzok, and his lover, FBI Attorney Lisa Page. One e-mail from Strzok to Page on August 5, 2016, stated that the "*White House is running this...*" This was an obvious reference to the role Obama played in orchestrating operation "***Crossfire/Hurricane***," the attempted coup against candidate and President-elect Donald Trump by communists and traitors in the outgoing Obama Administration.

Another equally damning e-mail was dated September 2, 2016, and sent from Page to Strzok after she had just attended a secret White House

### **THE JEWS' MEDIA WERE CO-CONSPIRATORS IN THE DEEP STATE'S ATTEMPTED COUP AGAINST TRUMP**

The moral and ideological heirs of Soviet agents once embedded in American journalism -- Walter Duranty, Herbert Matthews, and David Karr, among many others -- knowingly parroted allegations against Trump and his supporters that have since proved to be entirely fabricated by Hillary Clinton's 2016 campaign for president. Their role



was to create the illusion of "*confirming*" or "*verifying*" the contents of the phony and fabricated *Steele Dossier* by repeating its lies and making their "*reportage*" appear to be validations by *third-party* sources.

Jeffery Goldberg of ***THE ATLANTIC***, Michael Issikoff of ***YAHOO NEWS***, David Corn of ***MOTHER JONES***, Miriam Elder and Mark Schoofs of ***BUZZFEED***, and David Ignatius of the ***WASHINGTON POST*** obligingly collaborated in this treasonous conspiracy. The bagmen who handed them the *Steele Dossier* to publish were all well-known Hillary Clinton henchmen: one was a ***State Department*** subordinate of Clinton's named Jonathon Winer, and another was Clinton lawyer Michael Sussman of the infamous ***Perkins Coie*** law firm. Thus, the Jews' Media willingly participated in what turned out to be a treasonous criminal conspiracy to destroy a duly elected president.

### **THE "*STEELE DOSSIER*" WAS THE SOLE PREDICATE USED BY THE "*DEEP STATE*" TO SPY ON TRUMP:**

Several Obama holdovers were later exposed to have perjured themselves before the ***Foreign Intelligence Surveillance Court*** (FISA,) seeking warrants to spy on President Trump and his advisors to search for "*dirt*." Likewise, Obama's CIA Director (John Brennan) and DNI (James Clapper) clearly perjured themselves by stating under oath to Congress that the *Steele Dossier* was **NOT** used to obtain FISA Warrants.

We also know they traitorously conspired to effectuate a coup against Trump based on the *Steele Dossier's* lies, conceived and funded by Hillary Clinton. It took two years for President Trump to be thoroughly vindicated by the ***Mueller Report***, which was reluctantly written by many of the very same dirty cops who treasonously spied on him. Unfortunately, the stolen 2020 National Election delayed the prosecution of those involved.

## THE \$40 MILLION MUELLER INVESTIGATION WAS WAS A TOTAL SHAM:

Robert Mueller testified before the *House Judiciary* and *Intelligence Committees* on July 24, 2019, following publication of his “*Special Counsel’s Report.*” His purpose was to defend the results of his two-year, \$40 Million witch hunt investigating President Trump’s supposed role in “*colluding*” with Russia to steal the 2016 Presidential Election.

Under Oath and before these two House committees, Mueller denied having heard of *Fusion GPS*, the opposition research firm that actually fabricated the phony *Steele Dossier* for Hillary Clinton. This is staggering, since the *Steele Dossier* was the sole justification or “*predicate*” submitted as evidence to obtain **FOUR** FISA warrants to spy on Donald Trump, both before and after Trump was elected. During Mueller’s testimony, Rep. Steve Chabot (R-OH-01) innocently asked Mueller if he knew the name of the firm that compiled the *Steele Dossier*. In reply to Chabot, Mueller testified “*I’m not familiar with that.*” Later, in reply to questions about *Fusion GPS* and its owner, Glen Simpson, Mueller responded that such questions “*...are outside my purview.*”

For the *Special Counsel* never to have heard of *Fusion GPS* while investigating "*Russia collusion*" charges against Donald Trump, is the equivalent of the *Warren Commission* never having heard of Lee Harvey Oswald in its investigation of the Kennedy assassination.

### THE RUSSIANS ALWAYS PREFERRED HILLARY TO TRUMP:

The phony narrative that Putin preferred the election of Donald Trump to that of Hillary Clinton was Jews' Media disinformation. It never made any real-world sense because, as *Secretary of State*, Hillary Clinton sold 20% of our precious Uranium reserves to Russia in return for \$145 Million in bribe money contributed to her ***Clinton Family Crime Foundation*** by Soviet Oligarchs. The Russians discovered to their delight that Hillary was bribable and someone with whom they could "*do business*." The subpoenaed server and e-mails she destroyed might very well have exposed her sale of influence to Russia, and perhaps Classified Documents, as well.
