

"Misclassifying" Violent Crime

Geoffrey Chaucer is often credited with originating the expression "***murder will out***" in his 13th Century ***Canterbury Tales***. Yet, Chaucer never anticipated the kind of corruption and legerdemain that's rampant among black officials in America. Washington, DC has recently been exposed cheating on its murder statistics to make the job performances of city officials look better with "***fewer***" incidents of violent crime and "***lower***" violent crime rates.

A veteran cop in the ***DC Metro Police Department*** (DCMPD) named Carlos Bundy has blown the whistle on DC officials by claiming that they intentionally misclassify violent crimes -- especially murder -- to under-report the true extent of DC's violence. He alleges this tactic permits murderers and other violent criminals to "***remain on the street***" and continue to be a threat to public safety.

Bundy is a 28-year veteran, who was a sergeant in the District's homicide bureau from 2010 until 2018. He alleges in his lawsuit against the city that the DCMPD has routinely been "***mis-categorizing deaths as something other than a homicide in order to keep the District's homicide numbers down.***" (He might very well have added, "***to hide the incompetence of the DC's leadership.***")

Bundy claims in his lawsuit that the DCMPD "***purposely misled the public about the homicide rates in the District of Columbia***" by categorizing unnatural deaths as "***accidents.***" He alleges in his lawsuit that his superiors retaliated against him after he expressed concern about the practice of misclassifying likely homicides. The retaliation against him consisted of denying him days off and lower performance evaluations.

Bundy cited many anecdotes in which high-ranking DCMPD officials classified violent deaths as "***undetermined***" or "***accidental,***" even though autopsy reports cited physical evidence that should have classified those

deaths as homicides. He claims that the DCMPD often neglected to investigate highly suspicious deaths and declined to label them as homicides if there were no cooperating witnesses.

These allegations are consistent with earlier claims by other DCMPD cops, who allege that aggravated assault and theft are also routinely misclassified by the DCMPD's highest-ranking officials. It is claimed they engage in this practice to deflate the District's crime rates for each of those categories of crime.

The usual suspects -- n*ggers, race-hustlers, and black DC officials -- went nuts when President Trump claimed that DC's government has promoted *"...fake crime numbers in order to create a false illusion of safety."* For the 212th time, Trump was correct and his critics have been exposed to be lying douchebags.

The DOJ has initiated an investigation into this scandal. There has also been a **REAL**, profound and immediate decline in violent crime since Trump ordered the National Guard to patrol the dangerous streets of DC 10 days ago, attempting to *"...address the epidemic of crime in our nation's capitol."*

I recall writing on this subject before, and found disparities between the number of murders reported by the **Chicago Police Department**, and the totals reported by the **Cook County Coroner's Office**. The Chicago PD was *"cooking the books,"* whereas the *Cook County Coroner* had the legitimate figures.
