

More Profiles in Cowardice

On September 3rd, the U.S. House had an opportunity to rid itself of at least 300 pounds of ugly, black fat. It came in the form of a censure motion against massive Congresswoman LaMonica McIver (D-NJ-10,) for assaulting and obstructing ICE agents on May 9th of this year while ICE was busily enforcing U.S. immigration laws.
