

## ***"Trapping" Democrats***

The "*brain-trust*" that advises "*Democrats*" -- more accurately called the ***New Communist Party of the USA*** (NCPUSA) -- have warned their party not to allow Trump to continue "*trapping*" them into adopting ridiculous and unpopular positions on public issues. Of course, Trump hasn't done anything of the sort: it's just that when Trump takes a common-sense position on an issue, the NCPUSA reflexively takes the opposite and ends up with a mindless and indefensible stance on that same issue. It is *they* who have *trapped* themselves.

For example, violent crime has skyrocketed in Washington, DC, ever since its insipid black elected officials intentionally under-funded the DC Metro Police and adopted what is laughably called "*justice reform*." Under such incompetent and clueless *leadership*, there are rarely any legal consequences for violent and dangerous black teenagers. In response, Trump deployed ***National Guardsmen*** to assist the DC police, producing a profound and immediate decline in violent crime, including an 87 percent drop in car-jackings in just its first two weeks.



Yet, the reflexive opposition of most black officials persisted even after violent crime was dramatically reduced. **DC's black officials oppose Trump's crime control measures because Trump has exposed the insanity of DC's failed approach to law enforcement for all the world to see.** Obviously, retaining their offices has been a far higher priority for DC's black officials than the safety of its citizens. Trump showed DC residents that violent crime is not an inevitable feature of life, and that with competent leadership in place, life in DC doesn't have to be a dangerous and scary proposition.

Likewise, President Trump recently announced an expanded and aggressive **tariff policy** whose purpose is to compel fair trade by foreign nations. The policy is to be assessed against nations that have abused our good will and generosity for decades by embargoing U.S. goods, or imposing high tariffs on U.S. imports. His new policy elicited dire predictions of trade wars, trade disruptions and inflation from the same Trump-haters and MAGA-haters who previously permitted this imbalance to occur and did nothing about it.

**Their chorus of boos occurred because the success of Trump's new tariff policy has merely exposed their own incompetence and malfeasance.** For decades, the *Uniparty's* gross mishandling of foreign trade has permitted foreign nations -- both friend and foe alike -- to pick our pockets and run up vast trade surpluses against us. Trump is proving we needn't be taken advantage of by other nations -- nor incur massive trade deficits with them -- because we hold most of the aces when it comes to international trade.

If there's one issue that unites the NCPUSA, that's its opposition to Trump's **border wall** and the enforcement activities of ***Immigration Control and Enforcement*** officials (ICE.) **ICE** has arrested and deported tens of thousands of violent and dangerous illegal alien criminals, many of whom belonged to *MS-13* or *Tren de Aragua*, and most of whom had

arrest warrants issued against them for some violent or sex crime. Yet, a recent *Gallup Poll* indicated that less than one percent of registered "*Democrats*" approve of Trump's deportation policies.



**Latin Nations Don't Romanticize Violent Criminals Like the NCPUSA**

Clearly, the NCPUSA has a vested interest in illegal immigrants, and has callously subjected Americans to terrorists and violent criminals to further their political interests. The presence of illegals exaggerates the populations of **BLUE** states, permitting them undeserved numbers of congressional districts following each 10-year Census. That's why U.S. maps of Congressional Districts appear solidly **RED** (Republican,) with only a few, small **BLUE** ("*Democrat*") dots where large sanctuary cities have welcomed mass, illegal migration. **The NCPUSA opposes Trump's**

deportation of illegal aliens because it undermines their insatiable quest for power through their pursuit of Congressional majorities.

The NCPUSA has done everything in its power to obstruct Trump's enforcement of U.S. immigration laws. This includes establishing illegal sanctuary zones, interfering with arrests by ICE, and selling unused steel sections intended for Trump's border fence for *pennies-on-the-dollar* to scrap metal dealers.
