

Nimis Cito ex Arboribus

A recurring theme for the CofCC is that Western Civilization has been willfully "*unlearning*" the accumulated wisdom of many centuries when it comes to the subject of race. It's pretty clear that ideology has been the catalyst, with Cultural Marxism and its derivative ideologies the specific culprit. That's why knowledge in certain critical scientific fields has regressed over the past 100 years, even as knowledge in most other areas has exploded.

For 50 years following Charles Darwin's publication of ***The Origin of Species*** in 1859, there was a consensus within academia and the scientific community regarding the nature and origin of the profound differences between whites and blacks. They were presumed to originate from ***NATURE***, not ***NURTURE***, having evolved from differing adaptations to the diverse environments of different continents. Joseph Le Conte, a highly respected biologist in the mid-19th Century, concluded that Darwinian principles demonstrated that ***"The struggle for life and the survival of the fittest (were) applicable to the races of men."***

One dissenting voice was that of the black sociologist and historian, W.E.B. DuBois, although he ***DID*** concede the consensus view that blacks were predisposed toward ***"...immorality, crime, (and) laziness."*** (W.E.B. DuBois. ***The Philadelphia Negro***. University of Pennsylvania Press, 1899.) However, much like his fellow race-hustlers of today, DuBois blamed racism and discrimination by whites -- rather than the innate moral and mental deficiencies of blacks -- for their failure to adapt to modern societies and flourish within them. **Unfortunately, it is DuBois' excuses for black failure that now prevail within academia and government in the West, where misguided egalitarian impulses often ludicrously dismiss race as a "false construct."**

It's impossible to understand race relations in any century of America's existence without recognizing that the average IQ of black Americans is 15 to 20 points lower than the average IQ of American whites. (That disparity is twice as great among blacks still in Africa.) This enormous disparity "*explains*" all differences in income, academic achievement, and even rates of incarceration. *The Bell Curve* is a compendium of results from 650 empirical studies that prove this disparity. (Richard Herrnstein and Charles Murray. *The Bell Curve*. Free Press, 1994.) It affords such overwhelming proof that the subject must now be censored everywhere except within white nationalist circles.

As a result, most authors shy away from the subject of race and IQ. They fear attacks from the Jews' Media, as well as ostracism by the *Stepford Children* who enforce political orthodoxy in that vile cesspool known as "*social media*." Nobel Laureate James Watson, co-discoverer of DNA's molecular structure, was fired as the Director of **Coldspring Harbor Laboratory** merely for acknowledging racial differences in IQ. Yet, the evidence is clear: despite herculean efforts, America has been no more able to successfully assimilate the vast majority of blacks as productive

and contributing members of society than ancient *Alchemists* were able to convert lead into gold. As the brilliant Jared Taylor has written, "*People create cultures, cultures do not create people.*"

Our well-intentioned but misguided experiment with *egalitarianism* has failed miserably. The demonstrable failure of blacks to successfully assimilate -- even after hundreds of years of exposure to white civilizations -- is not the fault of whites or "*white privilege*" or "*systemic racism*," or "*institutionalized racism*," or slavery, as race-hustlers and their apologists parrot. The fault lies with blacks themselves who, when left to their own devices, rapidly cultivate a violent and squalid sub-culture displaying the lowest imaginable societal standards. Thus far, this phenomenon has proved to be irreversible and worse, most are unwilling to even recognize there *IS* a problem.

Over the last 150 years, America transferred the full range of rights, privileges and immunities to blacks, beginning with the ***Civil Rights Act of 1866***. It later ended *separate-but-equal* institutions among the races with ***Brown v. Board*** in 1954, and later declared a ***War on Poverty*** in the

1960s by launching trillion-dollar per-year welfare programs targeted at blacks. We also enacted endless civil rights laws such as ***The Fair Housing Act***, and even adopted ***racial preferences*** for blacks in employment and admissions. We eventually spent hundreds of billions on school desegregation, and trillions more on programs to eliminate the academic "*achievement gap*" existing between blacks and whites.

With the possible exception of the Egyptian Pyramids, no society has ever expended so much effort and so many scarce resources on a "*public good*," but received so little benefit in return. Despite it all, since the mid-1960s black poverty has consistently increased. Blacks today are significantly angrier, more violent, more dependent on welfare, more likely to be fatherless, more likely to be dependent on drugs, and far more likely to have been incarcerated in one of our state prison systems or county jails than 60 years ago. Blacks have become synonymous with violent crime, property crimes, welfare dependency, illegitimacy, drugs, venereal disease, and functional illiteracy.

Yet, while blacks reflexively site racism and discrimination to excuse their failings, Asian immigrants to America have often experienced profound hardships that no black in 160 years or more has ever experienced. Many Asian immigrants have arrived here with far fewer advantages and resources than blacks -- and often don't even speak English -- but by virtue of hard work and scholarship they frequently excel. Their intelligence, studiousness and law-abiding nature make blacks look very bad in contrast, and blacks know it. That's because the successes of Asians obliterate black excuse-making. This is why most blacks hate and resent Asians, and sometimes violently assault even those who are total strangers.

The simple truth is, blacks are not held back by race discrimination, they are held back by some very unappealing character defects that their enablers and apologists have labored to hide for decades. They are held

back by functional illiteracy, criminal records, poor work habits, ubiquitous drug use, and their often lazy, resentful and surly attitudes in a work environment. The poverty that blacks reflexively attribute to race discrimination is really just the consequences of impersonal forces operating in the labor market. That's because so few blacks have marketable skills, especially those who slept through 12 years of schooling. Professional sports prove this.

Those blacks who actually possess marketable skills are paid enormous sums by the **National Football League**, **Major League Baseball**, and the **National Basketball Association**. Likewise, Tiger Woods made Billions in the traditionally white enclave of professional golf, and several other "*persons-of-color*" have made many millions there, as well. This proves there's no discrimination experienced by blacks who actually possess marketable skills, *as opposed to those who merely claim they do*.

To argue that systemic race discrimination exists in the U.S. requires that one believe white Americans are willing to discriminate in every context of employment ***EXCEPT*** sports. Why would supposedly racist whites be any more tolerant of blacks in pro sports than in any other occupation or livelihood if they are truly committed to discriminating against them, as race-hustlers allege?

REAL and demonstrable race discrimination in 21st Century America may be as rare as unicorns, and perhaps even as rare as blacks who are honest enough to concede its absence. The *racism industry* is an important source of income and employment for many race-hustlers, so the intellectual heirs of W.E.B.
