After the George Floyd riots, many **BLUE** cities and counties adopted so-called "*justice reforms*" by de-funding police, allowing cashless bail,

granting early release of felons, and *decriminalizing* theft below \$1,000. This enabled dangerous felons to continue practicing their craft while awaiting their trials. Naturally, these "*reforms*" instantly produced skyrocketing rates of both violent crimes and property crimes. Under the Trump Administration, **BLUE** cities which have "*demonized*" law enforcement by adopting such phony "*reforms*" have already seen \$800 Million in **DOJ law enforcement grants cancelled**.

A similar approach is being taken toward cities and states that provide "*sanctuary*" to illegal aliens, a declaration intended to shield illegals from immigration officials. This makes the deportation of illegal alien criminals more complicated and dangerous. For that reason, ICE and other law enforcement officials have targeted sanctuary cities and states by "*surging*" in these areas where illegals are most heavily concentrated. Here again, the Trump Administration intends to **withhold federal funding** from these sanctuary cities and states, in addition to **suining these jurisdictions** in federal court, and **arresting public officials** who obstruct the enforcement of U.S. immigration law.

Several corrupt Obama holdovers engaged in perjury to unlawfully obtain FISA warrants to spy on President Trump during his first term, and then engaged in a treasonous coup to destroy him. These traitors were Former FBI Director Jim Comey, former CIA Director John Brennan, and former *Director of National Intelligence* James Clapper. It took two years for President Trump to be vindicated by the ***Mueller Report***, reluctantly written by some of the dirty cops who conspired against him. Comey is the most self-righteous and scurrilous of the these, but was recently **indicted for perjury** by Trump's DOJ. That's an example of accountability, not revenge.
