

Will Wonders Never Cease ?!

Proving that even a blind squirrel will occasionally find an acorn, *U.S. Supreme Court Justice Ketanji Black Jackson* -- the one who couldn't define "*woman*" during her confirmation hearings -- has found one. 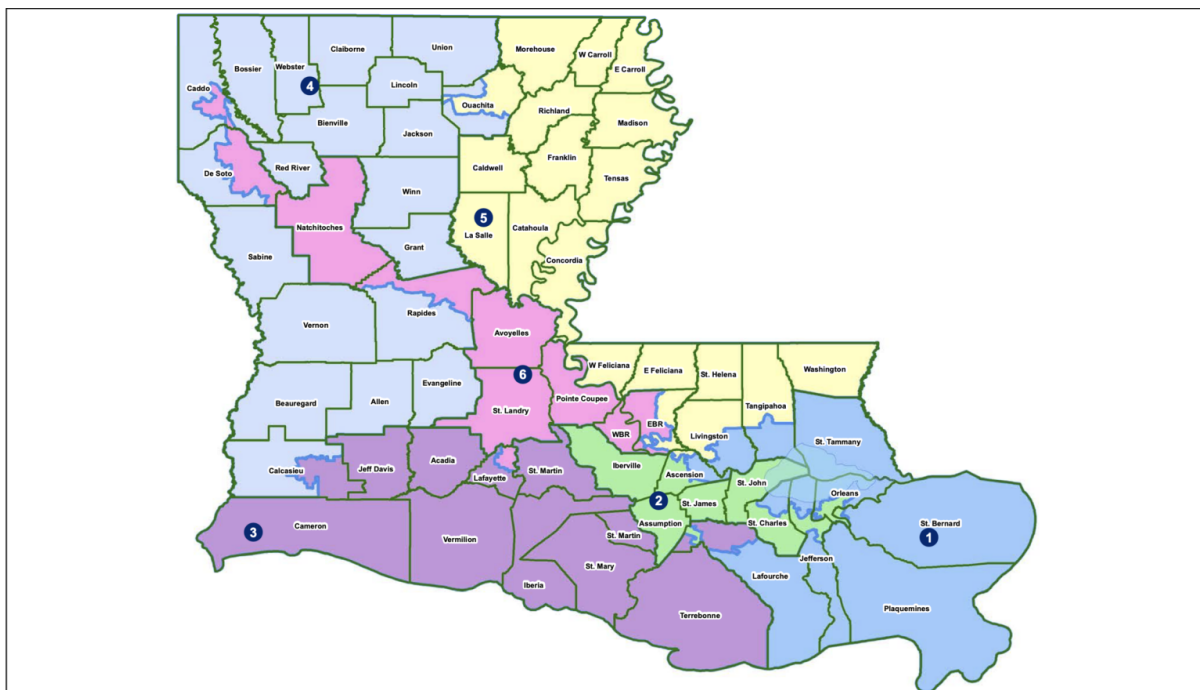


Ketanji Black Jackson

She continued, *"The idea in Section 2 is that we are responding to current day manifestations of past and present decisions that disadvantage minorities and make it so that they do not have equal access to the voting system. Right, they're disabled."*

We at the CofCC are confident that Justice Jackson has never read ***The Bell Curve***, an evaluation of the 600-plus empirical studies that exposed the ***REAL*** "disability" among blacks.
