

They **NEVER** Let You Down (cont'd)

Congresswoman **Sheila Cherfilus-McCormick** (D-FL-20) and her brother were recently indicted by a federal grand jury in Miami for obtaining COVID money by fraud. She then laundered those funds through the accounts of friends and family to hide their source, so they could be illegally contributed to her Congressional campaigns in 2021 and 2022.

In 2021, the Congresswoman's brother, Edwin Cherfilus, submitted 17 fraudulent invoices to the **State of Florida** to obtain \$5.8 Million in FEMA disaster relief funds for their family business, **Trinity Health Care Services**. As the CEO of **Trinity** at the time, Sheila Cherfilus-McCormick later transferred \$6.2 Million to herself from **Trinity** as "*profit-sharing*." She then distributed \$4.2 Million of her "*shared profits*" to friends and relatives, who turned around and illegally donated those funds to her campaigns as "*straw*" donors.

Congresswoman Cherfilus-McCormick's Congressional campaigns. Dan Backer, an attorney for a watchdog group, the ***Reagan-Coolidge Foundation***, stated the following to the ***WASHINGTON FREE BEACON***:

"The scope of this scheme is unprecedented, and this may just be the tip of the iceberg. . .Sheila Cherfilus-McCormick is a straight up crook, embezzling taxpayer funds to line her pockets and fund her campaign, and she and her whole crooked family should be prosecuted to the fullest extent of the law."

The three-term Congresswoman faces a maximum of 53 years in federal prison on her current charges.
